

TERMS & CONDITIONS: INSTANT \$120 OFF G 4977 VI SF / SCVI SF DISHWASHERS

Terms and Conditions of 2019 Miele® Dishwasher Promotion. (1) This promotional discount (the "Discount") from Miele, Inc. ("Miele") provides a one-hundred twenty dollar (\$120) manufacturer's discount on the Miele® G 4977 Vi SF dishwasher (the "Qualifying Appliance"), for a post-Discount advertised price of nine-hundred seventy-nine dollars (\$979) or on the Miele® G 4977 SCVi SF dishwasher (the "Qualifying Appliance"), for a post-Discount advertised price of one-thousand and seventy-nine dollars (\$1,079). (2) The Discount only applies to the advertised price of the Qualifying Appliance and shall not apply to any installation services, taxes (including sales tax), delivery services, disposal services or any other fees. (3) Only end users (consumers) may benefit from the Discount. The Discount shall not apply to builders, wholesale buyers or any person or legal entity who offers for resale, or resells, the Qualifying Appliance; in connection with such transactions or purchases, the Discount shall automatically be void. (4) The Discount may not be combined with any other offers or promotions. (5) The Discount shall be applied at the time of the payment for the Qualifying Appliance. (6) To qualify for the Discount, the Qualifying Appliance must be ordered in person or by phone at or from the store of a participating authorized Miele dealer or online through a participating authorized Miele dealer's website from April 1, 2019 through and including June 30, 2019 (the "Discount Period"). Purchases made on or before March 31, 2019, and subsequently cancelled and reissued during the Discount Period shall not qualify for the Discount. Purchases made during the Discount Period and subsequently cancelled and reissued after the Discount Period shall not qualify for the Discount. (8) In the event a Qualifying Appliance is returned to Miele or a Miele dealer after a Discount has been credited, the Discount shall be forfeited and must be refunded to Miele in its entirety at the retail end-user's expense. (9) The Discount on the Qualifying Appliance shall be limited to one (1) Discount per household except in Rhode Island or where prohibited by law. (10) The retail end-user shall be eighteen (18) years or older. (11) The Discount shall be voidable at any time at Miele's discretion if the retail end user violates the applicable rules. (12) No substitutions shall be allowed. (13) The Discount is only available to residents of the fifty (50) states of the United States of America and the District of Columbia. The Discount is not valid for residents of Puerto Rico, the U.S. Virgin Islands and any other territories or possessions of the United States of America. (14) Any misrepresentation by the person placing the order, whether innocent or fraudulent, shall disqualify him or her from the Discount; Miele reserves its right to refer such person for civil or criminal prosecution. (15) Miele may amend or discontinue the Discount for the Qualifying Appliance at any time with or without notice, including after the Discount has been credited. (16) In no event shall Miele be liable for more than the amount of the Discount. (17) The above terms and conditions are severable and, if one or more provisions shall not be valid under applicable law, the remainder shall be enforceable to the maximum extent permitted by applicable law.
